Dial Before You Dig

NULCA continues to develop a relationship with DBYD on a state and national basis, as we believe that our goals are very similar and that we can add-value to the DBYD process.

Dial Before You Dig (DBYD) are very responsive to the idea of NULCA and can see that our Members will play a valuable future role, complimenting their current program.

Recently President Shirlee Cook attended meetings with DBYD national and state representatives to discuss how NULCA Members can gain recognition through DBYD. The DBYD Board of Management encouraged Association to our work towards a minimum competency standard, training and accreditation of NULCA Members. This enables organisations such as DBYD to feel confident in recommending NULCA Member locators as opposed to non-NULCA member locators.

However, it will be some time before we see DBYD endorsing us on their web page, as we will need to prove that as an Association we are responsible and have a structured criteria

for membership. This will mean that all Members will need to undergo further training and hold professional indemnity and other insurances.

DBYD reviewed the NULCA Competency Standards and provided positive feedback. In addition DBYD has commended the move towards minimum compulsory training and the requirement for Members to provide key compliance documents covering Public and Professional Insurance and WorkCover when renewing or applying for membership.

Members can apply to use the DBYD logo in their promotional material and NULCA is now developing a protocol for the use of the NULCA logo by Members in their own publications and websites. Further information on applying for utilisation of the NULCA logo will be posted on the NULCA website shortly.



Cemetery Industry

NULCA representatives recently took the opportunity to make a presentation to a conference group of 150 cemetery managers in Victoria. The presentation outlined why cemeteries should utilise the services of a NULCA accredited locator, to correctly locate and map the underground assets within the cemetery grounds.

We would welcome similar opportunities to make presentations to other industry groups such as hospitals or schools. Please let us know if an opportunity arises in your area. ■

Industry Reference Group

President Shirlee Cook was pleased to represent NULCA at an Energy Industry Reference Group in Sydney in April. The purpose of the IRG is to develop an industry wide risk management plan and representatives at the meeting included: Energy Australia; Telstra; AWU TAPS; Agility; DBYD; DEUS; WorkCover NSW; and Sydney Water.

Following the NULCA PowerPoint presentation, the delegates in attendance unanimously expressed support for NULCA's endeavours and agreed that we have an important role to play on a national basis. The meeting agreed in principle that there is a role for NULCA accredited locators and that our drafted minimum standards of competency to be widely accepted. The IRG has requested that NULCA continue in an advisory capacity. ■

A preliminary meeting was held in Melbourne in March with Shirlee Cook, Gary Cowley and Chris Gavan. It was agreed that vacuum excavation locators face many of the same problems as with radio-detection in terms of the potential of hitting a conduit etc.

The group agreed that there is a need to develop some basic training, develop some generic descriptors and undertake risk assessment. It was also agreed that existing guidelines/ documents and legislation need to be reviewed in the context of vacuum excavation including EPA, DBYD, Telstra, Australian Standards, overseas and state based legislation. The committee is now in the process of collecting this information.

Some of the topics to be covered in the Vacuum Excavation Standard are:

- Occupational noise management
- · Occupational protective gloves
- Eye protectors for industrial applications
- Occupational protective footwear
- · Clothing for protection against hazardous chemicals
- Acoustics-hearing protectors
- Confined space
- Australian Standard for water jetting/pressures

Training

President Shirlee Cook has been working closely with the Secretariat to identify and assess various options for developing training for NULCA Members. Meetings have been held with several training groups who have assessed the NULCA Competency Standards and put forward proposals on approaches to training that support the competency standards and meet all government and compliance requirements.

The Committee of Management has awarded the contract to develop the course to J B Hunter Technologhy who was one of the three companies who provided proposals to NULCA, J B Hunter Technology, has supported NULCA Member from the start of the association. John Croxson is Managing Director of J B Hunter Technology and the current NULCA Vice-President.

J B Hunter's proposal is to develop competency based training for locating the underground assets of utilities including: the development of an overall course in underground asset location; development of generic utility training courses; development of these courses to meet the legislative requirements of states or territories, and those of individual utilities.

In terms of utility groupings, the following will be invited to participate in the training: electricity distribution and generation; gas; water; and telecommunications. It is envisaged that each utility will have its own competency therefore there would be a core competency that would be compulsory with optional electricity, gas, water and telecommunication endorsements.

More information on the training developments for NULCA will be provided for discussion at the AGM on 29 July. ■



World Locator News



Buncefield Explosion



This photograph was taken at 6.00am on 11 December 2005, at the Buncefield oil terminal, Lane Hemel Hempstead in the UK. The fire started due to a leak of fuel, vapour built up over some hours and finally ignited with a big boom. The cause of the ignition has not been identified.

No one was killed, only a few injuries given that it was 6.00am on a Sunday morning, however if it was a work morning then hundreds would have either been killed or seriously injured, as a number of the adjacent office blocks were destroyed and local houses badly damaged.



Pakenham, Victoria 19/10/2005

An Australian incident made it into *Underground Focus* November/December 2005, Vol. 19, Issue 8

Construction workers breached a natural gas main, forcing the evacuation of 60 people from an indoor sports complex for over two hours. The leak, from a 50mm polyethylene pipe, was the fault of a drainage contractor doing excavations outside the centre.

Manilla, The Phillipines 23/02/2006

Talk about a chain reaction—workers were driving pilings for a building construction project when they apparently ruptured a water main. This was first noticed when a sinkhole opened in a street and swallowed two vehicles. Then, the escaping water loosened soil around steel beams being installed for the building's superstructure, causing them to shift. Two hours later, a tower crane being used at the site collapsed, with the operator barely making it to safety. The mayor ordered the city engineering department to suspend the permit for the building construction and to start an investigation into why the accident happened.

Taft Heights, CA, USA 18/10/2005

Two homes were damaged and several hundred people had their water service disrupted after a construction crew punctured an 8-inch water main. Some of the water got into a sewer line where raw sewage mixed with water gushed from under manhole covers onto and down the streets. The water flowed out under 90psi pressure until the valves in the area were shut off. One home owner said the water flowed onto her property and ran under the home, causing the cement slab under the home to start to sink. The construction crew was digging for installation of a new sewer connection when they hit the line. Most customers had very low pressure for most of the day and lost water service completely while crews replaced the damaged pipe. Water service was fully restored about six hours later.

Montreal, Canada 12/10/2005

Cars in a parking lot were damaged by pieces of pavement launched by water shooting into the air from a water main break. A construction crew was checking the ground for contamination when they drilled into the main. The crew had been contracted to drill some holes and got down about six feet when they hit something hard. The next thing they knew, the ground lifted and the water blew. News videos of the scene show a geyser seven stories high. Police and fire officials were at the scene to keep onlookers back. The force of the escaping water lifted a bulldozer off the ground. ■

Planning for a Pandemic

To meet the avian flu threat, businesses need to:

Identify

Identify and assess essential business functions and processes, including key employees and the core skills needed to carry them out. Identify scenarios and assess the impact of a pandemic on your business, employees, suppliers and customers and develop appropriate contingency plans.

Plan

Plan for business continuation in the extreme case of up to 50 per cent staff absenteeism for extended periods due to sickness, family illness care and other staff shortages and alternate locations.

Review

Review and update sick leave, return-to-work and compensation policies in response to unique situations created by infectious diseases and particularly pandemics.

Communicate

Develop communication and collaboration plans for external stakeholders – including governmental agencies, key customers, suppliers and the community – for periodic and emergency communication.

Educate

Develop communication and awareness/education plans for employees for prevention, preparedness and response planning.

Ensure vigilance and employee education in protection and basic hygiene measure to minimise the spread of illnesses among employees and visitors, including promoting health check-ups and seasonal flu vaccines.

Supply

Develop supply chain contingency plans in case of disruptions that result in parts and products shortages and demand changes, especially in just-in-time environment.

Ensure mobility

Assess the potential disruption of domestic and international transportation networks, including air, sea, over the road shipping, and the impact of international and domestic travel restrictions in affected areas; Plan for long-term disability, fatalities and succession planning for key staff.

Develop contingency plans to establish flexible worksites and work hours.

Remote working

Widen and ensure remote electronic online access to allow workers to telecommute, teleconference and work and provide services from home if indicated by public health officials and civil authorities.

Test

Test and audit the plans for effectiveness and business resilience.
